NOTICE IS HEREBY GIVEN THAT a regular meeting of the City Council of Cut and Shoot, Texas will be held at the City Hall, 14391 Hwy 105 East, within the City, on April 9th, 2026 @ 6:00 PM, for the purpose of considering items of business described in the accompanying Agenda, to-wit:

AGENDA

- 1) Call meeting to order @ 6:00 PM.**
- 2) Invocation.**
- 3) Public Comments: Any citizen with business not scheduled on the agenda may speak to the City Council. Prior to speaking, each speaker must be recognized by the mayor. The council may not discuss or take any action on an item but may place the issue on a future agenda. The time allowed per speaker may be limited.**
- 4) Recognition by the City of Cut and Shoot to the family of Judge Spikes for his committed service as a city judge.**
- 5) Approval of the minutes of the previous meeting(s).**
- 6) Approval of financial report and City expenditures**
- 7) Consider and possible action on the authorization for a credit card application with FNB (replacing our current cards which were in Amy Wade's name with State Farm bank).**
- 8) Consider and possible action on water fees (ex. Pumpage Turnoff/Reconnect, etc) by adopting an Ordinance to amend the "Schedule of Rates and Rules of Operation".**
- 9) Consider and possible action on a report about the Sales Tax study by Lang Thompson.**
- 10) Consider and possible action regarding engineering matters, including water wells, water plants, water distribution system, compliance matters, streets, roads, contracts and development.**
- 11) Consider and take possible action, if deemed necessary, on report from A-1 Utility & Construction regarding operations in the water system.**
- 12) Consider and take possible action, if deemed necessary, on the report on Police activities**
- 13) The City Council may enter into executive session under Texas Government Code Section 551.071 to receive legal advice on proposed amendment to the Groundwater Reduction Agreement with the SJRA and receive update on illegal off premise sign on at or near 13040 Hwy 105 E in Cut and Shoot, Texas and outstanding invoices for water line damage by contractors.**
- 14) Reconvene into open session and take possible action on items discussed in executive session.**
- 15) Hear comments from the mayor and city secretary and/or councilmen.**
- 16) Adjourn**

If, during the course of the meeting and discussion of any items covered by this notice, City Council determines that a Closed or Executive Session of the Council is required, then such closed meeting will be held as authorized by Texas Government Code, Chapter 551, Section 551.071 – consultation with counsel on legal matters; Section 551.072 – deliberation regarding purchase, exchange, lease or value of real property; Section 551.073 – deliberation regarding a prospective gift; Section 551.074 – personnel matters regarding the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; Section 551.076 – implementation of security personnel or devices; Section 551.086 – deliberation regarding competitive matters of a public power utility ; Section 551.087 – deliberation regarding economicdevelopment negotiation; and/or other matters as authorized under Texas Government Code. If a Closed or Executive Session is held in accordance with the Texas Government Code as set out above, the City Council will reconvene in Open Session in order to take action, if necessary, on the items addressed during Executive Session.
