NOTICE IS HEREBY GIVEN THAT a regular meeting of the City Council of Cut and Shoot, Texas will be held at the City Hall, 14391 Hwy 105 East, within the City, on March 12th, 2026 @ 6:00 PM, for the purpose of considering items of business described in the accompanying Agenda, to-wit:

AGENDA

- 1) Call meeting to order @ 6:00 PM.
- 2) Invocation.
- 3) Public Comments: Any citizen with business not scheduled on the agenda may speak to the City Council. Prior to speaking, each speaker must be recognized by the mayor. The council may not discuss or take any action on an item but may place the issue on a future agenda. The time allowed per speaker may be limited.
- 4) Hear from Frank/Merlynn Hersom on the Proclamation on Commemorating the 250th anniversary of the United States of America and consider possible action or adoption of proclamation.
- 5) Approval of the minutes of the previous meeting(s).
- 6) Approval of financial report and City expenditures
- 7) Consider and possible action understanding to adopt resolution adopting a policy permitting the consideration of applications for primary depository bank services received from financial institutions that are not doing business within the municipal boundaries of the City.
- 8) Consider and possible action to instruct staff to publish Request for Applications for Depository Services as required by law and set date to consider applications.
- 9) Consider and possible action to accept and approve Certificate of Unopposed Candidates for the May 2, 2026 General City Election.
- 10) Consider, discuss and/or take possible action on Ordinance #152-an ordinance of the city declaring unopposed candidates in the May 2, 2026 regular city election to office: canceling the May 2, 2026, election: providing a severability clause: and providing an effective date
- 11) Consider and possible action on water fees (ex. Pumpage Turnoff/Reconnect, etc)
- 12) Consider and possible action, if deemed necessary, on draft ordinance for City Park regulations and mass gatherings at the park.
- 13) Consider and possible action regarding review of Water Plant No. 1 & Water Well No. 6 and 250,000 Gallon EST Bids possible recommendation of award pending approval from TWDB.
- 14) Consider and possible action regarding engineering matters.
- 15) Consider and take possible action, if deemed necessary, on report from A-1 Utility & Construction regarding operations in the water system.
- 16) Consider and take possible action, if deemed necessary, on the report on Police activities and the hiring of an additional full time police officer and a presentation by Justin Broughton of Homeland Security Program 287g.
- 17) The City Council may enter into executive session under Texas Government Code Section 551.071 to receive legal advice on proposed amendment to the Groundwater Reduction Agreement with the SJRA and receive update on illegal off premise sign on at or near 13040 Hwy 105 E in Cut and Shoot, Texas and pursuant to Section 551.074 to deliberate the appointment, employment, evaluation, reassignment, duties, of a public officer or employee; police department, police chief, city secretary, municipal court clerk.
- 18) Reconvene into open session and take possible action on items discussed in executive session.
- 19) Hear comments from the mayor and city secretary.
- 20) Adjourn

If, during the course of the meeting and discussion of any items covered by this notice, City Council determines that a Closed or Executive Session of the Council is required, then such closed meeting will be held as authorized by Texas Government Code, Chapter 551, Section 551.071 – consultation with counsel on legal matters; Section 551.072 – deliberation regarding purchase, exchange, lease or value of real property; Section 551.073 – deliberation regarding a prospective gift; Section 551.074 – personnel matters regarding the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; Section 551.076 – implementation of security personnel or devices; Section 551.086 – deliberation regarding competitive matters of a public power utility ; Section 551.087 – deliberation regarding economic

development negotiation; and/or other matters as authorized under Texas Government Code. If a Closed or Executive Session is held in accordance with the Texas Government Code as set out above, the City Council will reconvene in Open Session in order to take action, if necessary, on the items addressed during Executive Session.
